Transcript of minutes from the first post-fire meeting of Common Council

[Translated from Latin]

A Common Council holden in Gresham House on 10th day of September 1666 and in the 18th year of the Reign of our Sovereign Lord Charles II now King of England etc. before Thomas Bludworth knight Mayor of the City of London, Richard Browne knight & baronet Alderman, John Laurence knight and Alderman, William Wyld knight and baronet Serjeant at Law and Recorder of the City of London, William Bolton, Richard fford and Robert Vyner knights Aldermen, Robert Hanson and William Hooker knights Aldermen and Sheriffs of the same City and also the greater part of the Commons in the Common Council of the same City then & there assembled.

The Ruines to It is ordered That all the Streetes Lanes & Comon Passages

be cleared of in every Ward be p[re]sently cleared & veiwed of all Rubbish & other

Rubbish Obstrucc[i]ons by the late Inhabitants every one before his owne Grounds

And that noe other Labour be permitted upon the Ruines of the said late

dwellings till this worke be finished That thereupon such further

proceedeings & Councells may be followed for the Cityes Welfare and

Recovery As shall be convenient And that his Lo[rdshi]p doth forthw[i]th Issue out

This Court doth elect & choose the afores[ai]d Comittee or any two of the said Aldermen & fower of the said Comoners & such of the Aldermen & Com[one]rs as will attend to be a Comittee to consider of ffitt places for the severall prisons belonging to this City or any wayes or meanes to repaire the old pr[i]sons And to treate with the former Keep[er]s of the same about their rebuilding them upon such Termes as they shall finde Convenient And if they shall thinke it fitt to make use of any of the Gates belonging to this City for that purpose Then they are to consider of what fitt Allowances or Satisfacc[i]on ought to be made to the respective Office[r]s now inhabiteing the same and how and by whome And to report to this Court their Opinions therein and John Cole to warne & attend t[he]m It is ordered that a Comon Councell be held on every Wednesday

at Gresham house at ten of the Clock in the ffore noone at farthest

At which times the Aldermen and Comon Councellmen are appointed
